### Developments in Legal Frameworks for Mediation

### **Synopsis**

Singapore has introduced numerous legislative and civil procedural amendments to encourage parties to mediate their disputes early. As a jurisdiction, it has attracted significant attention after hosting the signing of the UNCITRAL Convention on Mediation in 2019 and becoming one of the first states to ratify it. This workshop looks at the impact of the legislation around mediation and their implications for practitioners and users on enforcement of the mediated outcome.

# Determining the Mediator and Mediation Style for Complex Disputes

### **Synopsis**

High stakes disputes are often marked by unique characteristics which require prior attention on the design of the mediation process. When preparing for a multi-party, cross-cultural, or cross-border dispute, care in the selection of the mediator, understanding how he will interact with each of the parties, and managing parties' expectation of the mediator, can enhance the chances of success. This seminar reviews classical mediation approaches and proposes how advocates can assess the suitability of each approach for their client.



# Shifting the Client from an Adversarial Mindset In Preparation for Mediation
